"LEGAL TAX, AND OTHER ISSUES
CONCERNING PRIVATE FOUNDATION
GRANTS TO AND INVESTMENT IN CHARITABLE
ORGANIZATIONS" – SEPTEMBER 25, 2019

The Nonprofit Law Section of the Georgia Bar put on a CLE event at the State Bar of Georgia on September 25, 2019 to discuss "Legal, Tax, and Other Issues Concerning Private Foundation Grants to and Investments In Non-Charitable Organizations." The Section invited John Tyler, the General Counsel, Secretary and Chief Ethics Officer of the Ewing Marion Kauffman Foundation and Natallie Keiser a senior associate with the Community Economic Development and Neighborhood Transformation at the Annie E. Casey Foundation to speak on the topic. Cassady V. Brewer of the Georgia State University College of Law moderated the panel and gave the attendees an introduction into the increasing intersection of the philanthropic world and the for-profit world.

The CLE had over thirty (30) attendees and discussed topics such as (1) why do most private foundations not engage in financial support of noncharitable/for-profit organizations? (2) what challenges does your private foundation face when deciding to invest in a non-charitable organization? and (3) does your private foundations have investment policies that restrict or prohibit investments in for-profit enterprises? John and Natallie both provided insights into their own private foundations and explained the different challenges they face when choosing to invest in a for-profit company. Additionally, attendees were able to learn more about the resources available to them and get better understanding of the issues that can arise with private foundation grants to and investment in charitable organizations.
