Women in the Profession Committee to Host Pro Bono Fair

he Women in the Profession Committee will sponsor a Pro Bono Fair on Oct. 8 from 11:30 a.m. until 2:00 p.m. at the offices of Kilpatrick Stockton in Atlanta. The Fair is designed to introduce young lawyers to the wide and varied opportunities to provide pro bono legal services. Rule 6.1 of the Georgia Rules of Professional Conduct provides that each lawyer in Georgia should aspire to render at least 50 hours of pro bono legal services per year. However, many new lawyers do not perform any pro bono services because they simply do not know how to get started.

This will be the second year the Women in the Profession Committee has sponsored the Pro Bono Fair. Last year, Justice P. Harris Hines of the Supreme Court of Georgia gave the keynote address, discussing the importance of pro bono services in the legal profession. Justice Hines talked about how rewarding pro bono work can be and about the difference that it can make in the client's life. Although Justice Hines leads a busy life as a Supreme Court Justice, he still finds time to handle pro bono cases, setting an inspiring example for young lawyers.

One hour of CLE credit is available and lunch will be provided. The pro bono legal service organizations expected to attend the fair to provide information about their services and organizations include the American Civil Liberties Union of Georgia, Atlanta Volunteer Lawyers Foundation, Catholic Social Services, Georgia Association for Black Women Attorneys, Georgia Law Center for the Homeless, Georgia Lawyers for the Arts, Georgia Legal Services Program, the Pro Bono Project, Atlanta Legal Aid Society, the Grandparent/Relative Caregiver Project, TeamChild Atlanta, and the Truancy Intervention Project.

Judicial Liaison Committee

The Judicial Liaison Committee provides an opportunity for younger lawyers to interact with members of the judiciary in a variety of settings. The co-chairs of the committee are Michael Goldberg, Antavius Weems and Laurie Jablow.

One of our main projects involves setting up a seminar called "Meet the Judges," where we will have speakers from the judiciary and a roundtable discussion with judges from the metro Atlanta area. This seminar has proven to be extremely popular and is scheduled for February 2005.

During our first meeting, we will discuss possible speakers for the seminar as well as the possibility of setting up a similar seminar outside Atlanta.

This year we are also trying to come up with new ways to organize social events with judges and provide more informal meetings between younger lawyers and members of the judiciary.

Employers' Duties and Problems Committee

Our committee develops CLE programs and materials for employers and attorneys concerning labor and employment matters, including, but not limited to, harassment and discrimination issues, wage and hour laws, workers' compensation concerns, non-compete agreements, collective bargaining, and other federal and state laws applicable to the employer-employee relationship. Specifically, the committee organizes two CLE programs each year - one in Atlanta in the fall, and one in another Georgia city in the spring. The spring CLE program allows committee members to present materials of their own on labor and employment topics. For 2005, we are considering holding the spring CLE in Savannah.

In addition to the CLE programs, the committee also publishes a pamphlet entitled "What Georgia Employers Need to Know," which is distributed by the Secretary of State to all newly incorporated entities. The pamphlet includes an overview of the federal and state law applicable to employers.

Kids and Justice Committee

Looking for a fun way to get involved in your local community? Want to make a difference in a child's life and motivate them about learning? Want a good excuse to get out from behind the stacks of paperwork that are piling up on your desk? Try getting involved with a local Kids and Justice project!

Kids and Justice is a YLD sponsored program that gets practicing attorneys into local elementary school classrooms to teach fifth graders basics of Georgia law and what it means to be an attorney. The program uses lesson plans developed by the Law Related Education (LRE) Consortium that provide a great structure to your local project. However, you can work with your local school to develop a program that meets the needs of both the volunteers and the classes.

A past project in Athens had about a dozen attorneys who rotated teach-

ing two lessons per month during the school year. The lessons are coordinated with the 5th grade curriculum. For example, Constitutional Law topics are taught by attorneys at the same time the students are learning about the signing of the Constitution in American History. In the spring, the Athens project culminated with a simple Mock Trial. Students assumed the roles of judge(s), attorneys, witnesses, etc. while they were coached by local practicing attorneys.

The amount of time involveed is determined by you and the sponsoring teacher. You could visit the class once a week or just a few times during the school year; whatever you are willing and able to commit to and your school is willing to support.

With the school year just starting, now is the time to contact your local elementary school and introduce yourself and the Kids and Justice program. The difference between sitting behind your desk while talking on the phone and standing in front of twenty-five 5th graders teaching them about Georgia's laws on robbery and forgery is amazing and a tremendous break during your work week. You also get the benefit of showing your face in the local community and gaining a real sense of service to your local schools.

Legislative Affairs Committee

The Legislative Affairs Committee is made up of YLD members who take a keen interest in the state legislature, and it promotes awareness as to upcoming legislation that will impact Georgia's legal profession. The committee's highlight for the 2004-2005 year is its hosting of the 16th annual Legislative Affairs Breakfast, which will be held in January at the "Sloppy" Floyd building in Atlanta.

The purpose of the meeting is to not only raise awareness amongst YLD members of the need for lawyer-legislators, but to also inform the YLD membership as to pending legislation that, directly or indirectly, impacts Georgia's legal profession. The breakfast is an incredible opportunity to meet and visit with the speakers in a casual setting. In addition to the breakfast's featured speakers, younger lawyers also have the opportunity to meet other leaders of

the General Assembly, in addition to Supreme Court Justices, appellate judges, and trial judges. Last year's event was a huge success. Legislators Chuck Clay and Thomas Bordeaux were the featured speakers, in addition to Justice Robert Benham of the Georgia Supreme Court and Court of Appeals Judge John Ellington.

Women in the Profession Committee

The Women in the Profession Committee, chaired this year by Janet L. Bozeman, Lipshutz, Greenblatt & King, LLP, and Katrina Quicker, Kilpatrick Stockton, LLP, has a commitment to serving its members and the Bar by providing opportunities for legal education, networking, and community service. The mission of the committee is to explore issues of interest to women lawyers in Georgia. Three lunch and learn programs are planned for the year on topics of interest to committee members. The committee will also again sponsor the Women of Distinction program in the spring to honor women members of the bar who have made a significant contribution to the practice of law and the advancement of women.

Criminal Law Committee

The committee's focus will be to reach out to all interested attorneys in the criminal law field throughout the state and to provide an opportunity for networking with other young lawyers. The committee has already begun to work with members of the State Bar Criminal Law Section and hopes to organize events with both groups. The committee plans to hold meetings in Atlanta, Macon, and Gainesville in an effort to bring the committee to the areas where young lawyers are in practice. The planning for this year's CLE is also almost completed and there has been a significant focus on presenting speakers who may be a useful resource for younger lawyers. This year's CLE focus is on expert witness testimony. Tentatively there will be experts in a number of fields who will be presenting at this year's CLE on Oct. 21. Speakers are currently confirmed in the areas of eyewitness identification, mental health, firearms/ballistics, trace/fiber evidence, forensic document examination, fingerprint and crime scene experts.



2004 Celebration of Excellence Bigger and Better

he 2004 Celebration of Excellence was a huge success, due in part to the generous support of the State Bar and its members. The Celebration is an annual graduation ceremony and scholarship program that recognizes the academic achievements of youth in the Georgia foster care system who are graduating from high school, GED programs, vocational school, and college. These youth have overcome the significant barriers to academic achievement that come with instability of multiple foster care placements and changes in schools. Graduation itself is a remarkable testimony to their determination and hard work.

This year, the Celebration was at its biggest and best. On June 10, a record number of 280 graduates were honored at the Fox Theatre for their outstanding accomplishments, and more than \$66,000 in scholarships was awarded to qualified applicants who are continuing their educations! More than 600 people attended to share in the successes of the graduates, including judges, attorneys, legislators, foster parents, and child welfare professionals.

Gov. Sonny Perdue and the First Lady Mary Perdue made an appearance to welcome and congratulate the graduates. In their warm remarks, they spoke of how proud they are of the graduates' accomplishments. Frank Ski, host of the Frank Ski Morning Show on V-103 FM, emceed the event and assisted Division of Family and Children Services Director Dr. Janet Oliva in awarding each graduate a certificate of achievement. This year's keynote was magician and inspirational speaker Eric Anderson, who as a youth had personal experiences with the foster care system. He entertained and motivated the audience with his personal story and observations on life. Each graduate also received a gift bag full of donated graduation gifts including disposable cameras, long-distance phone cards,

from the Editor

The ABCs of Practicing Law

ometimes I have to remind myself to go back to the basics. For example, in sports, I have to remind myself to keep my eye on the ball. The minute I take my eye off the ball is the minute I strike out, or miss the catch, or send the golf ball 150 feet into the woods. In life, I have to remind myself of basic truths – what has lasting importance and what does not. When I get my basic priorities out of whack, my life follows suit. And in law, I have to remind myself of certain fundamental principals that I should never forsake. I have to remind myself of the ABCs of practicing law.

A – Accessibility As younger attorneys, we need to be accessible. The number one complaint to the State Bar of Georgia from clients is that their attorney would not return their phone calls. Do you return phone calls promptly? Our clients need to not only be able to reach us, but they need to know that we will in turn reach them as well. A prompt phone call back to your clients tells them that their issue, whatever it may be, is important to you. If you follow this fundamental policy of promptly returning phone calls, you will establish with your clients an essential foundation of appreciation and satisfaction. Remember, although their case may not be the most important case on your agenda, it is the most important case on their agenda.

B – **Believability** There is a significant difference in believing *in* someone, and believing someone. Believing in someone invokes the picture of a spectator, someone who stands on the sidelines and agrees that you can do what you say. Believing someone, however, involves the necessary element of trust. We must give our clients rea-

son to trust us. We do that by showing genuine concern for our clients' welfare, successes, pains or problems. We do not make promises that we cannot keep, such as assuring a victory, guaranteeing our clients of a certain monetary recovery or capping a bill when we are unsure whether fees will exceed it. We are honest and forthright, even if it means the client will be disappointed. What we say should match what we do. Anything less than this erodes the trust we seek.

C - Creditability Do you have "credit" with clients, judges, opposing counsel, etc.? Think of it like a bank account. For example, you make deposits in your clients' accounts by returning phone calls promptly, keeping your clients apprised of the status of their cases, and being candid in your handling and assessment of their cases. When things go south, for instance, when no settlement offer comes forth, or fees on the case have skyrocketed, or you make a mistake, do you have "credit" with your clients upon which to draw? If you have treated your clients with honesty, integrity, forthrightness, and true concern in your past dealings with them, then there is a good chance your clients will allow you to make a "withdrawal" when times get tough. But when no credit has been deposited over the course of your relationship with your clients, withdrawals on their accounts are a recipe for disaster.

Have you put in to place the ABCs of practicing law? If so, I commend you. If not, reverse the cycle and take whatever measures are needed to institute these fundamental principles into your practice.
