## STATE BAR OF GEORGIA YOUNG LAWYERS DIVISION SWEEPS ABA ACHIEVEMENT AWARDS

The Georgia Young Lawyers Division ("YLD") was recognized at the American Bar Association's Annual meeting in Chicago for the quality of its work in the 2000-2001 bar year. In the annual "Awards of Achievement" competition, the ABA's Young Lawyers Division recognizes excellence among state and local bars in four categories: Service to the Public, Service to the Bar, Comprehensive (based on the totality of programs conducted throughout the year) and Newsletter. The state and local bars compete in divisions that are based on population. The Georgia YLD, with 8,800 members, competes in Division IA (bars having a young lawyer membership of 8,000 or more) against bars such as the Texas, California and New York YLDs.

The Georgia YLD essentially "swept" the competition and received awards in all four categories, including three, **first place awards!** The YLD won first place in the Comprehensive, Public Service and Bar

Service categories. Georgia continued its seven-year streak of award winning newsletters by capturing second place in the newsletter competition.

The YLD received first place for all programs implemented throughout the 2000-01 bar year. Projects such as the Aspiring Youth after-school tutoring program, the Great Day of Service, and the Thirteenth Annual Legislative Affairs breakfast, were among those included in the Georgia YLD's award application.

The Comprehensive Pro Bono Initiative won the Best Service Project to the Public. The Pro Bono Committee Chairperson Tracey Roberts of Arnall, Golden & Gregory, LLP, who was in Chicago for the awards, said "winning is a reflection of the committee's hard work in conducting both the Associate's

## 2001 Celebration of Educational Excellence Recognizes Largest Class Ever!

The 2001 Celebration of Excellence was a grand success thanks to the support of many organizations and individuals! This year's statewide Celebration recognized children who grew up in foster care and who graduated from high school, a GED program, vocational school, and college. During their stay in foster care, many youth experience changes in placements which often means that they must change schools. The fact of their graduation is a remarkable testimony to their determination and hard work. On June 21, a record 192 graduates were honored at the Fox Theatre for their outstanding achievement, while over 600 people from the legal, child welfare, and larger community attended to cheer them on.

Each graduate received a certificate of achievement from Governor Roy E. Barnes and a gift bag full of donated items, including disposable cameras, long-distance phone cards, pen sets, and a \$250 voucher toward future educational expenses. In addition, nearly 40 scholarships were awarded to qualified applicants attending post-secondary schools to continue their education. This year's keynote speaker was Lynnette Cole, Miss USA 2000, who is herself a former foster child. She spoke powerfully about her own experience in foster care and inspired our graduates with her own achievements.

Special thank you to the State Bar of Georgia/YLD for its continued tradition of supporting the Celebration and the foster youth of Georgia. Without that support, we could not have hosted such a successful Celebration and honored these youth who have overcome so much on the road to success.

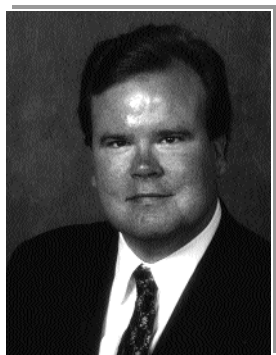

## YLD Adds New Committee Which Promises Great Personal Satisfaction For Its Members

The Young Lawyers Division of the State Bar of Georgia has added an exciting new committee to expand its service to the public. The Disability Issues Committee is an excellent opportunity to become more involved in your community, as well as the YLD. What is most appealing about this Committee is that it promises great personal reward for its members, with a minimal time commitment.

The Disability Issues Committee's objective is to deliver legal services to persons dealing with physical and mental disabilities. However, for this upcoming year, the Committee intends to focus on legal services for the mentally ill. This year's project is aimed at organizing a program that will provide access to quality legal advice for Georgia residents suffering from mental illness, including support for families dealing with mental health issues. In this project, volunteer attorneys assist the staff of a partner organization, the National Alliance for the Mentally Ill - Georgia Chapter ("NAMI"), in responding to callers with a wide variety of legal problems. The attorneys involved in the project will respond by explaining legal proceedings and providing information and advice for protecting legal rights and remedies, and by facilitating better communication between family members. In addition to providing this immediate aid to the caller, this project also encourages and educates attorneys to address the legal needs of the mentally ill in the attorneys' daily practice.

This year's project will certainly have an enormous impact in Georgia. A caller to NAMI who needs legal assistance or advice will be referred to a motivated volunteer attorney, who provides or coordinates an appropriate and helpful consultation or other response to the caller's specific inquiry. This project limits its plan to coordinating a response to an initial inquiry, and does not seek to provide an attorney *pro bono* for full-blown legal representation of every caller. However, volunteer attorneys are encouraged to provide legal service to a caller to whatever extent the attorney believes is necessary and appropriate under the circumstances.

At this point, the project will be limited to the metropolitan Atlanta area, with the hope that it can expand to other areas in Georgia. The Committee hopes to recruit a group of motivated volunteer attorneys with a sufficiently broad range of expertise. The attorney may direct the person to available resources for legal representation, or arrange terms to represent the client him/herself. As noted, the project does not ask volunteer attorneys to agree to provide full-blown legal representation of every caller. Instead, volunteers are asked to commit to responding to an average of five inquiries a year, and are committed to providing a written or oral response to the caller's inquiry or an appropriate referral.

This is an excellent opportunity to make an enormous impact in Georgia, with a relatively small time commitment. If you are interested, please

### COME TO THE NEXT MEETING AND SEE

In early 1999, while reading then-President Ross Adams' column in this newsletter, it seemed to me that YLD was a great organization *if* you lived in Atlanta but, if you didn't, it wasn't really relevant. Being young and impetuous, I decided to call Ross (whom I had never met) and express this sentiment. I got more than I bargained for.

Ross very patiently listened to my complaint. He then told me that the YLD was a great organization for Atlanta and the entire state. If I wanted to help expand its reach to areas outside Atlanta, I should come to the next YLD meeting at Callaway Gardens in March and see for myself what it was all about. After I hung up, the usual thoughts ran through my head: "Oh, well, gee, I am really busy"; "Callaway is a long way from Augusta"; and "I don't know a single soul who will be there".

Despite my misgivings, I did go to that Callaway meeting. That experience is one I will never forget. The first night, I met the nicest people from all over the state. I was introduced to Joe Dent (then-president elect) who was from Albany (gosh, that's smaller than Augusta and farther from Atlanta). I met several people from Savannah (who, by the way, has one of the best young lawyer groups
